COVENANT TOGETHER!!

Covenant: a mutual agreement between two or more persons to do or not to do certain acts. When we first started talking about visioning for our church I thought back to the time when I was in a covenant group with four members in our church. We wrote our own covenant and then met once a week to hold each other accountable. I wondered what would happen if we as a church would covenant together and then hold each other accountable.

Covenant one: Acts of Worship

"I agree to attend worship regularly and to be in a worshipful attitude." It is so easy to come to church out of habit and forget that the main reason we come is to worship God. It is easy to come with a critical eye - not liking the music, picking apart the message, the service was too long, etc. If we come to worship with a critical eye we will find things to be critical about. If we come with an open heart and a loving spirit we will leave being filled and challenged.

Covenant two: Acts of Devotion

"I agree to spend time every day reading a devotional (possibly the Upper Room) and also the Bible."

Having a quiet time alone to read and reflect is a time to grow in our faith and in our trust and become closer to God. Draw near to God and he will draw near to you.

Covenant three: Acts of Compassion

"I agree not to gossip, not to start a rumor and not to spread rumors."

Ask yourself, is it nice, is it necessary, is it true? Then ask yourself, even if it is true, is it necessary for me to tell someone? Gossip is so damaging, so hurtful and has no place in the church. In our covenant group we found that once we made this covenant, we were very uncomfortable around gossip. The best thing to do is keep our mouth shut and/or stand up for the person being talked about. In our church family we want to and need

to lift each other up, pray for each other and be there to support each other.

I, personally, would like to see us come together in covenant as a church family – coming together in one spirit, with one purpose – to grow in our faith and in our love for each other, to become the people that God created us to be.

"We are a family of God – we are children of the King – fill us with your Spirit, help us to live a life pleasing to you, and may the love of our Heavenly Father cover us and make us one. Amen."

FRONT'N CENTER

Our time together in worship is divided between two essential elements: the time of preparation when the body of believers gather to prepare their hearts to receive God's blessing, and the proclamation of the Word when the scripture is read and preached. This is approximately two-thirds preparation and one-third proclamation. In a typical worship experience only one-third is utilized for the preaching by the pastor and the remaining time is in the hands of the remaining persons there, the laity.

There has been an on-going critique concerning the spirit of our worship. As I stated above the majority of the worship is dictated by the laity; if people want something different in worship, then they have to be willing to be involved in changing it. It all boils down to participation; if no one participates other than sitting still and being ministered too, then worship will not change.

The body sets the tempo of the worship, not the pastor. The pastor's part of the service is bring the Word and leading the sacraments. If you want a more vibrant worship, if you want to experience God in a new way; then you have to be willing to participate in making it happen. If you want to clap your hands, then clap your hands. If you want to dance in the aisle, then dance in the aisle. If you want more energy, then be more energetic. If you want it to be more spiritual, then pray and be spiritual. If you want an altar call, then come to the altar and seek prayer. If you want to see lives transformed by the power of God, then ask God to begin with you. If you want to hear personal testimonies about how God is working in someone's life, then share your testimony.

The body has forty minutes every Sunday to set the tone of the worship. The purpose of worship is to prepare ourselves to hear the word of God; to offer God praise for sending Jesus Christ into our world and to express our thankfulness for the salvation of our souls.

This is an invitation to each of you to be active participants in our worship. You do not need my permission. Worship is our time together with God and God created each of us in a unique way. God has given to each special gifts to share with one another and when we fail to share them we are defying God and cheating one another from the blessings God has placed within us. Let us be respectful of each other's unique gifts and let us share the gifts within us to honor God in our worship.

Administrative Council Meeting Minutes Tuesday, August 19, 2014 6:00 p.m.

Chair Paul Kammarmeyer called the meeting to order at 6:00 p.m. After joys and concerns were shared Pastor Mike led us in prayer followed by the Lord's Prayer.

Motion was made by Kathy Waterman, seconded by Bill Scanlan to approve the July Ad Council Minutes as written. Motion carried.

Randy asked for clarification of the article in the Chimes stating that SPPRC had approved the change to one service. Although it had been discussed at various times no official action had been taken by that group. Due to declining attendance an executive decision was made at the April Ad Council by Pastor Mike to continue with one service after the summer until such time two services are warranted. The financial report was approved as presented including sending of \$709.72 for designated apportionments in July.

Pastor Mike led discussion on moving towards a single group of people comprised of various teams meeting monthly as a decision making body for the church instead of various meetings of teams throughout the month who then report to ad council. This would help to streamline the process and cut down on meeting times. More information will be available in the future.

Randy Waterman reported that as SPPRC chairperson he has been asked by our secretary to remove scrip sales from her duties. It was pointed out that those sales are not part of her job description and are disruptive of her time. It will be suggested to the scrip committee that help be found during the week for scrip sales. Also it was suggested that scrip sales be conducted out of the conference room instead of by the welcome center, keeping that area for fellowship and focusing on our worship experience.

Reports of God's Work:

Connectional reported that a Church Fun Night will be held on Sept. 14 at the Sherman Pumpkin Patch. Those who attended last year had a great time and Dean and Jackie are happy to host us again. The corn maze will be open and Connectional will provide a light supper of hot dogs, chips, s'mores and drinks. There are many fun things to do there for all ages. Connectional will also be looking at going to the Meadows again this fall to visit with members who are there. Anyone is welcome to join us. The residents do enjoy our visits. Again Bingo is every fourth Tuesday of the month with our next date being August 26. You are invited to join us as we help with Bingo which starts at 2:00 p.m.

The church library has received memorial monies that will be used to purchase a Bible study series and additional books. We appreciate families considering us a source of a memorial to their loved ones. The library has been well used this summer and we hope to add some new items to the collection this fall.

Additional reports:

Before adjourning the meeting, Chairperson Paul Kammarmeyer announced he is stepping down as our chair for personal reasons. Meeting was adjourned at 7:20 with Bill Scanlan leading us in prayer and singing of the doxology.

Finance Meeting Minutes August 12th, 2014 5:30 pm

Present at the meeting:

Pastor Mike, Paul Roberg, Kathy Evarts, Deb Saunders, Roger Mueller and Kelsey Anderson.

The meeting was called to order by Pastor Mike at 5:36 pm; Pastor Mike opened with a prayer.

Debbie explained the reports as shown. One change to the report is as follows, Scrip donation (\$2,500.00) was applied to an incorrect fund number. This line item was corrected in the accounting program.

Apportionments/Designated Apportionments: Pastor Mike noted that though we are negative in general operations we have a balance in the reserve that is available to use if necessary to send in for apportionments. After discussion, Kathy Evarts moved to send in only the designated apportionments, \$709.72. Roger Mueller seconded the motion, with all in favor the motion carried.

First action item:

Kelsey Anderson addressed the board for clarification on the funding of the youth program.

Pastor Mike and Paul Roberg explained the details of Finance's budgeting decision (October, 2014):

MUMC has budgeted \$625/month for the youth group. This will be paid first through designations. If designations exceed \$625 in any given month, the additional income will be held for future months. However, if designations are below \$625, MUMC will pay the difference if the following conditions are met: (1) We pay salaries, utilities, expenses, designation apportionments, (2) there are excess contributions that exceed these expenses, (3) equal division among all accounts (Library, Missions, Trustees, Education, etc.) To date, the budget has run in the red and these conditions have not been met; therefore youth group (as well as all fund accounts) have only received the amount that has been designated. Kelsey explained her purpose for attending the meeting was strictly clarification. The youth group account has sufficient funds at this time; however, she wanted to protect the integrity of Finance's decision. The issue of fundraising was addressed; the committee explained that the youth group can fundraise for applied projects, and not program expenses.

Second action item:

Debbie reported that a member of the congregation has graciously stepped forward to volunteer to work alongside her with the finances. After discussion, the board decided it was the purpose of the Finance Committee to help in the office with any financial issues that Debbie may have. At this time, the board has respectfully declined this offer. Debbie reported that she has progressed in learning the Power Church Plus program and feels it is unnecessary to switch to QuickBooks or any other program for now. She would like to finish the year out and assess the situation at a later date. The board will revisit this action item in the fall.

Kathy Evarts gave a report on Scrip sales. The summary of July scrip sales and year-to-date sales for 2014:

July 2014 Sales were \$12,705 with a profit of \$571.33 plus AOP profit of \$18.93

July 2013 Sales were \$17,985 with a profit of \$793.45 plus AOP profit of \$109.33

Year-to-date sales for 2014 as of the end of July were: \$88,670 with a profit of \$3,981.06 plus \$68.22 of AOP profit

Year-to-date sales for 2013 as of the end of July were: \$117,280.70 with a profit of \$5,313.89 plus \$321.58 of AOP profit

Decrease in sales of \$28,610.70

Decrease in profit of \$1,332.83

Roger Mueller commented on the music situation regarding payments, it has been recommended the person (people) turn in their monthly bill or forfeit their earnings. This is an item for the Ad Council to address, the discussion was closed.

Pastor closed the meeting in prayer at 6:22 pm.

Buy Scrip!

This month's article focuses on the financial situation of scrip. In short, we are not doing nearly as well in 2014 as we have in the past several years. Year-to-date sales for 2014 as of the end of July were: \$88,670 with a profit of \$3,981.06 plus \$68.22 of AOP profit. Year-to-date sales for 2013 as of the end of July were: \$117,280.70 with a profit of \$5,313.89 plus \$321.58 of AOP profit. This indicates a decrease in sales of \$28,610.70, and a decrease in profit of \$1,332.83. That is a rather substantial decline and one which the scrip committee is concerned about.

It's hard to pinpoint exact reasons for this decrease, but contributing factors probably include the horrible winter we had with the accompanying decline in attendance, plus the period of time between secretaries when scrip was not available for purchase during the week.

How can we turn this situation around? That is up to YOU, the congregation!! If you are not currently buying scrip, why not? Any team member would be happy to answer your questions and help you get started. If you have bought in the past and have fallen out of the habit, let us help you get back in that mode. And if you're just not sure how it all works, read the July and August Chimes articles. It's one of the easiest ways to contribute financially to your church, and it does make a difference - in the four years 2010 - 2013 scrip sales contributed \$21,102.75 to the budget. All those little bits do add up! Remember, when you buy gift cards through scrip you support **YOUR** church.
